Images of its progressive decrease (from about 25,000 km^2 in the 60s to less than 1350 km^2 today); of lakeside communities whose sources of subsistence are in decline; droughts, deprivations and conflicts dominate the specialized understanding of the current conditions in the Lake Chad region. These conditions, along with institutional weaknesses and government failures, are the main drivers of vulnerability and insurgency in the region. The conditions at Lake Chad provide a dynamic test field of wide relevance for understanding the major connections between humans and the environment, particularly in relation to sustainability and resilience issues in the Anthropocene. Sustainability, in this sense, encompasses the need to recharge the lake and restore it to a level where it can continue to sustain local livelihoods and regional economies. Where this is not possible, it will be necessary to proactively update the resilience of sites. This can be done by increasing the capacity of lakeside communities to create alternative livelihood options and seek strategies that increase their competence to address the emerging threats associated with the degradation of Lake Chad.
