

#### Schedule

The schedule is concurrent with the 11th biennial AIA Design for Aging Review competition. The 11th biennial call for submissions will be in May (2011) and the AIA Design for Aging Review competition will be open for submission from June 1st (2011) to July 31st (2011). The jury is assembled in mid to late August, with the results ready for presentation at AAHSA early November 2011.

#### Awards

The winner of the student competition will be recognized for outstanding achievement and will be exhibited at the 2011 AAHSA annual meeting in Washington DC and the 2012 AIA national convention. These designs will also be included in education programs and the upcoming 11th edition of the Design for Aging Review companion publication.
