Taking account of the time left before the end of the Parliamentary term, it would be advisable to take into account the Rule 214 on **Unfinished business**:

*At the end of the last part-session before elections, all Parliament's unfinished business shall be deemed to have lapsed, subject to the provisions of the second paragraph.*

*At the beginning of each parliamentary term, the Conference of Presidents shall take a decision on reasoned requests from parliamentary committees and other institutions to resume or continue the consideration of such matters.*

In the point 5.1 it will be discussed the hearing on "Implementing the discard ban" scheduled for 7 April 2014, and closely linked to this proposal.

Decision: For the attribution of the Report there are two proposals on the system to apply: to attribute the report to the President or to attribute the report to a Political Group that will table a Working document. The decision is taken after a ballot with the following result: first option: EPP-ECR-ALDE in favour; S&D, Greens and GUE/NGL against, EFD abstained (majority) – second option: S&D, Greens in favour, EPP-ALDE-ECR-EFD against, GUE/NGL abstained.  
The first option is adopted.

### **4. Delegations**

#### **4.1. Delegation to Germany 24-26 March**

A formal letter has been sent to President Schulz with a detailed justification of the visit to Germany. A programme for the visit has been drafted together with the office of Mrs Rodust. It also includes the visit of the fish ladder in Geesthacht, as proposed by the ALDE group.

So far the following Members are interested in participating: Ms Patrao Neves and Mr

Antinoro (EPP) and "hors-quota" Ms Rodust (S&D) and Ms Meissner (ALDE).

Decision: Calendar and Members participating are confirmed.

#### 4.2. Visit to the Visit to the European Fisheries Control Agency in Vigo, Spain

On the Conference of Committee Chairs held on 14 January 2014, the Committee on Fisheries was invited to submit a request as soon as the exact dates are determined. It was emphasised that Agency visits must take place during weeks set aside for external parliamentary activities.

The most appropriate week to organise this delegation would be the last week of October (green week): 27-31 October 2014 which coincides with the delegation to Greece (27-29 October).

In this same week it is foreseen the delegation to Greece. Nevertheless this fact should not be a problem. Some members could attend the visit to the EFCA while other members attend the delegation to Greece.

Decision: Visit to Vigo (2-3 October); Visit to Greece (27-29 October).

### 5. Hearing

#### 5.1. "Implementing the discard ban" scheduled for 7 April 2014

This hearing is closely linked to the proposal sent by the Commission on the landing obligation and discussed under the point 2.1.1.

Decision: The hearing will take place on 7 April 2014.

### 6. Any other business

#### 6.1. Task force on multiannual plans

The Interim report has been sent to the members on 10th December 2013.

Decision: on 28 January the Commission will present a second interim report. For middle of March the Task Force has to conclude its work in order to join a Political Agreement. A slot of the last meeting on 17 March will be kept. It'll verify the possibility to use this date for a meeting of the Task Force on Multiannual Plan.

#### 6.2 FPA EU/Madagascar – adoption in committee

Adoption in committee of the Rivellini's report (PE 500.521v01) on the Proposal for a Council Decision on the conclusion of the protocol agreed EU/Madagascar (COM(2012)0505 – 2012/0238(NLE)). This report was expected to be voted in committee during the meeting on 20<sup>th</sup> March 2013. The rapporteur agreed with the shadows, decided to postpone the vote in committee till the political elections foreseen for the last May 2013 (1<sup>st</sup> round) and for 20<sup>th</sup> December last (2<sup>nd</sup> round). The elections were held regularly and without incident, as underlined by the EU observer.

Timing scheduled: adoption in committee in March 2014, Plenary April II 2014.



Decision: Calendar for the adoption in committee and Plenary agreed.

6.3. [European Maritime and Fisheries Fund \(EMFF\)](#)

The rapporteur and the shadow rapporteurs held a meeting last week in Strasbourg to analyse the situation. Following the latest development of the file it has been discussed the possibility to continue the negotiations.

In this meeting, it was agreed to wait for the contact between Mr Cadec with the Commission.

Decision: tomorrow an informal meeting between the three institutions is scheduled, in order to prepare a trilogue for the next week.

6.4. Oral question proposed by the EPP Group on “Seabass conservation at European level”

Decision: The Political groups will make the necessary pressing in order to include this OQ together with the OQ on the Status of the North-East Atlantic mackerel fishery and the OQ on the Legal status of the Svalbard Archipelago and its fisheries resources, in the Agenda of next plenary session.
