The Proposal for a Council Regulation on the establishment of the European Public Prosecutor Office [COM (2013) 534 final] is based on Article 86 of the Treaty on the Functioning of the European Union (TFEU) which establishes a special legislative procedure to combat crimes affecting the financial interests of the Union and it requires unanimous action by the Council after obtaining consent from the Parliament. The main objectives of the proposal that creates the European Public Prosecutor office (EPPO) are "to contribute to the strengthening of the protection of the Union's financial interests, to establish a coherent European system for the investigation and prosecution of offences affecting the Union's financial interests, to ensure a more efficient and effective investigation and prosecution of offences affecting the EU's financial interests, to increase the number of prosecutions, leading to more convictions and recovery of fraudulently obtained Union funds, to ensure closer cooperation between European and national competent authorities and to enhance deterrence of committing offences affecting the Union's financial interests".

The Rule 81(3) of the Parliament's Rules of Procedure states that "the committee responsible may decide, in the interests of achieving a positive outcome of the procedure, to present an interim report on the proposal to Parliament including a motion for a resolution containing recommendations for modification or implementation of the proposed act". The LIBE Committee has taken the responsibility of drafting an interim report and CONT is associated to that procedure under the Rule 50 of the EP Rules of Procedure with a proposal by the Rapporteur Ingeborg Gräßle containing draft recommendations in its field of competence.

A CONT delegation travelled to Bulgaria from 28 to 30 October to visit the nuclear power plant of Kozloduy as part of decommissioning of nuclear power plants and also paid a visit to the audit office and the Ministries of Energy and Finances. A brief meeting with a stakeholder in the area of energy concluded the programme in Sofia. In the context of the accession negotiations and to increase nuclear safety, Bulgaria, Lithuania and Slovakia committed themselves to closing and decommissioning their non-upgradeable reactors. For that reason, and for the recognised social, economic and financial burden of that commitment,



the European Union provided a financial contribution to these countries that has been assessed by the Court of Auditors.

Exchange of views and consideration of a working document, in the presence of the Member of the European Court of Auditors responsible, H.G. Wessberg

The CONT delegation decided to visit the nuclear power plants (NPP) in those three countries and the visit to Bulgaria was the last of the three missions that CONT committee devoted to this matter.

The delegation examined the progress of decommissioning process in Kozloduy and reached the following conclusions:

- The dismantling of Kozloduy NPP (KNPP) was a BG decision, is credible, effectively taking place and its progress is overall satisfactory;
- Each decommissioning project raised different issues and therefore it is not possible to draw all conclusions;
- The decommissioning team is very professional and engaged;
- The division of competences between KNPP and SERAW in the decommissioning process is still not fully clear;
- Information on the length of the remaining lifetime of the reactors, on the complete removal of the fuel rod from reactors 1-4, on the final storage of radioactive material and on the effective use of the spent fuel containers was required following the delegation visit;
- The financial shortfall remains unknown because of the different figures provided but there was a general agreement that a plan for plugging the gap is essential;
- The delegation would like to see more engagement from the National

Parliament and from the Bulgarian National Audit office in monitoring the funds use in the decommissioning process;

- The work of the audit activity directorate within the Ministry of Finances in its effort to ensuring an efficient implementation of the projects co-financed by the European Funds is recommended;
- EUR 260 million is available in the next financial period only for decommission purposes and therefore mitigation measures will be dependent on national funding.

5. SPECIAL REPORT NO 14/2013 - EUROPEAN UNION DIRECT FINANCIAL SUPPORT TO THE PALESTINIAN AUTHORITY



Since 2008, the largest programme in the occupied Palestinian territory (oPt) has been PEGASE Direct Financial Support (DFS) which provided approximately 1 billion euro in funding from 2008 to 2012. The main rationale of PEGASE DFS is to help the Palestinian Authority (PA) to continue to function until the achievement of the two-state solution and also channels assistance to meet PA's obligations to civil servants, pensioners and vulnerable families and to maintain essential public services and improve public finances.

The overall objective of the Court's audit was to address the following question: *'Have the EEAS and the Commission managed the PEGASE Direct Financial Support (DFS) to the Palestinian Authority well?'* To answer this question, the audit focused on (i) the design and implementation arrangements for PEGASE DFS from 2008 to 2012, (ii) the results of PEGASE DFS and their sustainability and (iii) related technical assistance contracts, notably in the area of public finance management, signed during this period.

The Court identified a number of shortcomings in the Commission's management of the PEGASE mechanism *inter alia* the lack of standard internal quality review procedures and performance indicators in the financing agreements, the absence of a risk assessment addressing issues such as corruption in Gaza with regard to the payroll system, and the persistent weaknesses in the Palestinian Authority's public finance management.

The Rapporteur welcomes the special report examining the EU direct financial support to the Palestinian Authority as an important contribution to the overall political and financial debate about the European Union's engagement with Israel and Palestine with a view to supporting progress towards the two-state solution.

He points out the necessity to undertake a major review of PEGASE and particularly emphasises the need to

reinforce the programming phase of the future of PEGASE DFS by introducing performance indicators, particularly in the areas of health, education, and public finance management and linking more closely PEGASE to the new EU-PA action plan priorities and by using competitive tendering for contracts relating to the management and control of PEGASE DFS.

He also suggests developing a clear strategy on how to reduce the PA's dependency on EU financial support, to introduce benchmarks such as creating functional institutions as an incentive for the PA to receive EU funding and requests the Commission and the EEAS to discuss with the PA regarding the increasing number of PA civil servants in Gaza who are receiving salaries from the PEGASE DFS without working.
