The two rapporteurs, Mrs Krehl and Mr Van Nistelrooij, made a presentation on the advancement of the negotiations on the CPR. The rapporteurs informed the Members that a document reflecting all the elements negotiated since the end of the summer recess had been distributed to Members.

The rapporteurs explained to the committee that since the vote in July of the report, the negotiations went on and that at this moment around 95 % of the PR was agreed, with dozens of chapters finalised. However, there were several important issues where there was no progress as the Commission and the Council remain unmoved. The remaining problematic

issues as follows:

- Performance reserve;
- Macroeconomic conditionality;
- Co-financing of projects;
- Pre-financing of projects;

The Rapporteurs declared that the Negotiating Team was doing everything in order to advance in the negotiations.

The rapporteurs also presented the main details of the new proposal for support to SMEs that the Commission had brought to the trilogues at a very late stage. They informed the committee that it was agreed by the REGI NT that the SMEs issue would be undertaken once the on-going problems, specially the macro-economic conditionality would be solved provided that time is available.

The committee agreed with this strategy and no objections were raised on the rapporteurs' proposals.

The Chair has added that all negotiations have to come to a close on October 10th if the vote in plenary is maintained for October II session.

The meeting adjourned at 11.15 and resumed on Tuesday 24 September 2013 at 15.10 with Danuta Maria Hübner (Chair) in the chair.

It was decided that the subject regarding the "Assessment of the administrative capacity of Member States and regions for Cohesion policy implementation" should be included in the on-going study on the "EU Member States preparedness to an effective and timely start of the new Cohesion Policy Programming period".

It was also decided to request a new study on the "The role of cities in Cohesion policy 2014-2020". The details of the study will be further developed by the Secretariat and the Policy Department.

V. NOTE

REGI committee has to deliver two opinions (Rapporteur for two opinions: Patrice Tirolien) to adapt a Directive and a Regulation following the change of statute of Mayotte, which will become an Outermost Region as of January 1st 2014.

Because the text has to enter into force on January 1st 2014, the leading committees (ENVI and PECH) **have to adopt their reports on November 27th and the texts will be voted in**

plenary in December (or January) at the latest.

Therefore, REGI has no time to debate and present draft opinions. We will open a deadline for AMs on these two legal texts until **September 30th at 12 p.m.**

We will be voting the AMs and the draft opinions on 14 October.
